5. Planning: (Planning Report for discussion circulated to Cllrs. prior to meeting) **Planning Applications:**

23/00521 - 6 detached dwellings consisting of 3 no. one and a half storey, 2 no. two and a half storey and 1 no. 2 storey dwelling together with formation of access and associated hardstanding following demolition of existing industrial buildings - Butlers Court Farm, Blean Common - Blean Parish Council object to this application on the grounds that the flood risk assessment makes no reference to the discharge from the Gladmans Waste Water Treatment Plant, on the planned neighbouring site on Blean Common which has recently been granted, and is thought will flow in this direction.

This application is being called into committee. To Discuss: Correspondence from Goddard Planning.

7.3 Footpath Report: Clir. Samuelson and Clir. Russell.

7.4 Highways Report: Cllr Jeffers.

There are potholes on the road near the bus stop at the Royal Oak which had previously been identified by the KCC Highways Steward following the surfacing in the road improvements scheme. Cllr. Jeffers has reported it to KCC.

Cllr. Akers said that he has made numerous complaints about road issues.

Five volunteers attended a recent session which was a practice as sessions need to be booked in advance.

7.6 Clerks Report:

Recreation Ground

The Rowan Tree planted in the recreation ground to commemorate the late Queen's Platinum Jubilee has been replaced due to it not growing very well.

The Defibrillator check was completed by the clerk on 30th May and updated on The Circuit website. The CCF Funding Agreement 2023/2024 was signed by the Chairman & Clerk and returned to CCC. A copy is kept by BPC.

The tree work in the recreation ground as identified in the tree survey has been completed by Goodfellers Tree Surgeons.

Dates of forthcoming meetings in the coming year unless for any reason they have to be changed. 10th July, 11th September, 9th October, 13th November, 11th December, 12th February 2024, 11th March 2024, 8th April 2024 and Annual Parish Council meeting on 13th May 2024.

8. Matters raised by the Public:

David Gammon reported that the footpath that runs through the farm is overgrown making it difficult to access. The relevant footpath number will be identified and the clerk will report it.

9. Matters to be discussed: (Any relevant papers circulated to Cllrs. prior to the meeting).

9.1 Crab & Winkle/Tyler Hill Road Crossover.

Cllr. Thomas said that at the meeting which was held in November 2022 concerning this issue it was noted that the bike imprint on the road and red coloured tarmac surface was done before 2009. He suggested that maybe CCC can help especially Ward Cllr. Ricketts as he is now a Transport Strategy cabinet member.

10.1 Cllr. Russell reported on the plastic-free initiative which continues with the launch in Canterbury on 5th July with a gathering of people at The Drapers Arms. Cllr. Russell will ask Rosie Cullen whether she would like to attend.

10.2 Cllr. Akers said that he is happy to collate a village newsletter.

10.3 Ward Cllr. Jupe asked whether a basketball hoop can be installed on the recreation ground.
