**5. Planning:** (Planning Report for discussion circulated to Cllrs. prior to meeting) **PLANNING REPORT August & September 2023** 

#### **Planning Applications:**

23/01088 - Retrospective application for single-storey detached agricultural storage building - Lyndale, 24 School Lane - Blean Parish Council are disappointed that this application is Retrospective, and note that it was previously refused and dismissed at Appeal due to not sufficiently demonstrating the use of the land for 10 years between 2011 and 2022.

23/01024 - Detached two storey dwelling and single storey detached car port - 36 Tile Kiln Hill - Blean Parish Council objects to this application on the same grounds as the previous application: Unacceptable rear land infill contrary to linear development; Not identified in housing need survey; Lack of visibility splays; Impact on the neighbouring properties; Additional traffic; No gray water harvesting; Impact upon PTP technology; Lack of vehicle charging points.

23/01231 - Detached two-storey dwelling - 51 Whitstable Road - Blean Parish Council object to this cramped backland form of development which is out of keeping with the surrounding development. The proposal will be overbearing and overshadow the bungalow to the north. Also, object to this plan because of the nutrient neutrality issues at Stodmarsh due to the extra output to existing sewerage infrastructure.

**23/01201** - T.P.O No.26 of 1990, T1 - T21 - To cut back laterally 21 Oak trees up to a maximum of 5-6 metres, trees located in paddock and overhanging from neighbouring land - **3 Woodville - Blean Parish Council has no objections to this application.** 

23/00973 - Creation of new vehicle crossover - 47 Blean Common - Blean Parish Council has no objection to this application subject to the existing ditch in front of the property not being affected.

**23/01317** - TPO No 26 1990, To Coppice area of woodland approx. 2 acres but retaining all single stem trees - **117 Blean Common - Blean Parish Council has no objection to this application.** 

**23/01354** - Two-storey side and rear extension, porch to front elevation, single-storey detached garage together with replacement boundary fence following demolition of existing single-storey side extension - **2 Honey Hill** - **Blean Parish Council has no objection to this application.** 

**23/01436** - Application for Listed Building Consent for external and internal alterations including insertion of doors, replacement windows from timber to timber, window to door, installation of wood burner and flue with flue cap to chimney, removal of ceiling, rooflights, replacement bay window to ground floor - **Church Cottage, Tyler Hill Road - Comments by 15**<sup>th</sup> **September**

**23/01265** - Application for lawful development certificate for proposed installation of Solar PV panels to roof and EV charging point to garage wall – **18 School Lane** - **Would be lawful** 

**23/01201** - T.P.O No.26 of 1990, T1 - T21 - Crown lift the lateral limbs to appropriate growth points up to 8 metres height along length of the field and woodland boundary including over the stables - **3 Woodville – GRANTED** 

### 5.1 Planning Breach 23/01354 2 Honey Hill

Ward Cllr. Ricketts reported that a Planning Officer had attended this site last week and spoken to the applicant who understands that any work being done is at their own risk. The Parish Council are disappointed that this practice is allowed to happen.

CCC Planning are waiting to hear from KCC that they are happy with the revised plans for a turning circle.

It was noted that some lovely trees have been taken down and BPC would hope that substantial landscaping will be taking place on the site.

# 23/00973 - Creation of new vehicle crossover - 47 Blean Common

Although this application has not yet been decided it has been noted that the ditch at the front of the property has been filled in despite the Parish Council commenting that this must not be allowed to happen as the ditches in the village are important for drainage.

We are waiting for Landscape Services to provide a quote for digging out and cutting the ditch in the

recreation ground.

Canterbury City Council has today begun consultation on proposed changes to the public highway at **five** separate locations in Canterbury. These are:

- changes near the Westgate Towers and creation of a Westgate Square
- changes near the clocktower and creation of a St George's Square
- changes along St George's Lane and to the bus station
- changes to the pedestrian and cycle routes to the Norman Castle
- changes to footways on Pound Lane between The Causeway and St Peter's Lane

It should be noted that work on the public highway is subject to approval by Kent County Council (KCC) and a road safety audit process. This may restrict our options when it comes to layout and materials.

The schemes being consulted on are all subject to the money being available and on our ability to deliver them.

CCC are also holding two public events where you can come and talk to council officers about proposals.
