

### Minutes of the Annual Parish Assembly held on Monday 8th April 2024

Prior to the April Parish Council meeting the Annual Parish Assembly was held to which all residents were invited. This took place in the Community Area of the village hall with refreshments provided.

The Chairman welcomed everyone to the meeting and introduced the speaker for the meeting.

The speaker was Sara Valencia, who is the Landscape Community Organising Officer of Kent Wildlife Trust, who gave a very interesting and informative talk and presentation on the update of the Wilder Blean Project.

#### What is the Blean complex?

Sara showed a map of the Blean Complex.

#### Why is the Blean important?

### The Wilder Blean

Large herbivores reintroduced to the woodland as natural engineers.

A more biodiverse, resilient ecosystem.

People are advocates for the project.

Create model for the rest of UK, based on international best practice.

#### Phase one - Bison

Blean Bison Project.

West Blean and Thornden Woods.

They will be building four bridges next year.

#### Phase two - Wilder Blean Initiative

Aim: Restoration of complete natural processes to a lowland English woodland.



Monitoring: We need to first understand what the status quo is, what wildlife already lives in West Blean and Thornden Woods, and what the vegetation and soil look like in the project area before we start introducing our grazers.

- 34 bird species
- 16 lesser spotted woodpeckers
- 826 invertebrate species
- 142 soil samples to be analysed for soil fungi and bacteria eDNA
- Small mammals and reptile data incoming

- Regularly on site to help with any and all questions
- Encourage everyone to follow the code of conduct Education hub
- Development of the Heather Corry Ranger Station

### **Planning Applications:**



CA/24/00198 & CA/24/00199 Single storey rear extension together with single storey detached outbuilding. The Oast House, Pean Hill, Blean, CT5 3BH – A small minor point but it is odd that the application form states that the applicant is Mr and Mrs Jon Oliver but the Design and Access Sheet 2363

Statement states Mr and Mrs P. Crocker as the applicant ? Blean Parish Council are concerned that the agent is proposing a single ply flat roof to the proposed extension to this grade ii listed building , also that the proposed window design in Blean Parish Council's opinion would appear out of character with the existing rear windows . The views of CCC Conservation Officer on this would be interesting to know. No comments on the rear outbuilding.

**Note:** The broken pavement outside 47 Blean Common has been repaired by KCC. This occurred as a result of a creation of a new vehicle crossover which has, of yet, not been granted planning permission.

Councillors commented that CCC need to improve their website for planning as it is difficult to comment when the website is so restrictive and accessing planning documents is difficult. Ward Cllr. Smith agreed to report this back to CCC.

### 6.1 Draft Canterbury District Local Plan To 2040 - Land to North of University.

BPC along with Cllrs. from Hackington and Rough Common Parish Councils are meeting with CCC on 30<sup>th</sup> April and will chase the University for a meeting with them also. A list of questions to be raised with CCC will be drawn up.

It was agreed that a meeting with all three Ward Cllrs. is needed.

#### 7.2 County Cllr. Thomas

Cllr. Thomas said that the University land was previously ruled out because of the proposed bypass but the 'Bus First' strategy has allowed this to be put in the Draft Local Plan.

Three manhole covers on Blean Common have been reported to KCC as being loose and causing disturbance to residents. The Highways Steward is investigating as KCC, Southern Water, UKPN and Openreach all say they are not their responsibility.

**10.1 Clir. Hutt** reported that there appears to be a water leak leading from Woodlands Estate. **10.2 Clir. Russell** reported on a meeting that had taken place between residents of Tyler Hill Road and a CCC Officer regarding the flooding of back gardens and water in the ditches which is very high along the second half of the Crab & Winkle Way. The road to the church is about ten inches deep and there is no place for the water to go. CCC don't have any plans of the ground area. **Sheet 2366** 

A neighbouring resident said that Kent Highways are aware of the flooding and the ditch has now been dug out.

County Cllr. Thomas said he is happy to liaise with the resident.
