## 6.1 County Cllr. Report – Cllr. Robert Thomas

Cllr. Thomas said that due to purdah there is not much to report but spoke on the following:

- Village Hall Improvement Fund
- Rural Bus Shelter Scheme
- Vacancy for the position of Deputy Head at Blean Primary School
- Wild of Blean Project
- Highway Improvement Plans (H.I.P.)
- A290 issues

Cllr. Flack said that BPC's H.I.P. included the Crab and Winkle crossover at Tyler Hill Road.

#### 6.2 Ward Cllr. Ricketts

In his report Cllr. Ricketts agreed with the problem at the Crab and Winkle/Tyler Hill Road crossover with cyclists not looking as they cross Tyler Hill Road.

He also spoke of the recent accident on the A290 with speeding cars and said BRAKE are campaigning and have their next safety week in November.

He reported that CCC Policy Committee meet next month when electric charging points will be discussed.

#### 6.3 Ward Cllr. Flack

Cllr. Flack reported that the matter of the felling of the trees in Chapel Lane as reported at the last meeting has been resolved. There has been a change of ownership and the present owner has planted 300 trees.

Cllr. Samuelson asked about the electric scooters that are around Canterbury. Cllr. Flack explained that it is a legal trial by BIRD between the University/K & C hospital/train station etc. If they go off route they cut out. CCC Enforcement Officers are allowed to stop any illegal scooters.

Cllr. Ricketts thought it a good idea although needed to be separated with pedestrians. Cllr. Flack said she will take it up again with BIRD. Cllr. Smith thought there were problems with educating people and there needed to be feedback to allow control. County Cllr. Thomas commented that this is a trial but needs to work in a safe manner and the Police have a role to play as well as CCC and KCC. He urged people to keep reporting back.

## 7. Reports and Updates:

#### 7.1 Village Hall Report: - Cllr. King

Cllr. King reported that the news is encouraging and there have been requests for bookings for next year.

Nothing to report at the present time. They asked for footpath maps to be sent to them.

#### 9.1 For Discussion: Nature Reserve sign

## 9.2 For Discussion: CCC Capital Grant Application – Basket Swing

Cllr. Flack thanked Cllr. Hutt for starting the process of filling in the application form, she will fill in the extra bits and the clerk will complete the financial part. The Parish Council will contribute two years of Vat refund which amounts to £3,000 with Cllr. Flack, in her role as Ward Cllr, donating her Members Allowance of £500. She will make a similar donation to the other two Parish Councils in her Ward.

Cllr. Samuelson thanked her for this on behalf of Blean Parish Council.

## 9.3 For Discussion: Gladmans Appeal

Cllr. Flack said there are a considerable amount of documents from Gladmans for reassessment. Cllr. Jeffers said that most documents are updated. Cllr. Flack is to meet with the Planning Officer dealing with the case and there is to be a virtual meeting between all parties on 19<sup>th</sup> May.

# 9.4 For Discussion: Future Parish Council meetings – Government 'Call for Evidence' regarding virtual meetings

Cllr. Flack explained that, according to Government guidelines, virtual meetings cease on 7<sup>th</sup> May with face-to-face meetings having to take place with social distancing. The 'call for evidence' consultation calls on Parish Councils to give their experiences on the remote meetings they have held. Cllr. Flack asked Cllrs. to send their thoughts to the clerk in order to get our response in by 17<sup>th</sup> June. Cllr. Thomas said there is a legal challenge regarding the decision about virtual meetings.

As far as Blean PC is concerned, the committee room is too small to meet and any future meetings will be dependent on whether the village hall can accommodate us in the community space or the main hall if they are not already booked.

Due to this ruling, it was agreed to hold the Annual meeting virtually on Tuesday 4<sup>th</sup> May, maybe not have a meeting in June, and perhaps things will be in a better position by July. Cllr. Samuelson said he felt strongly that the Parish Council should not meet until September. It was agreed to carry on as we are until we know how the village hall are going to work. Cllr. Smith suggested alternative venues, e.g. University to meet, but it was thought there would be a cost implication and it would be too far for residents to attend. Cllrs. unanimously agreed for the clerk to continue to work from home.

## 10. Councillors' Reports:

**10.1** Cllr. Hutt reported on the increase in traffic on the A290.

**10.2** Cllr. Jeffers agreed with Cllr. Hutt about the increase in traffic on the A290 and the concerns he has over the condition of the road which he had reported on-line. He had an automated response with a reference number and when he tracked the report it said that the works had been completed, which they had not, so he had made a formal complaint to KCC. Cllr. Thomas said he will look into the matter. Cllr. Jeffers asked for a footpath map to be sent to him.

**10.3** Cllr. King said Mrs Dunster had asked him to say that she had nothing to report on the condition of the pavements. Cllr. Flack asked Cllr. King to thank Mrs Dunster.
