South Quay Shed in Whitstable which is very impressive with all the units being leased. It is hoped to have them all open by the end of June with all the businesses being local traders.

New Riverside Development:

This is hoped to be open by mid to late summer with twelve other units and a cinema. The quality is excellent with affordable schemes.

Cllr. Samuelson commented that he had noticed that in the advertising posters for this development there were no disabled persons or people of colour.

## 11.1 Village Hall Report: - Cllr. King

It has been necessary to completely replace the heating apparatus and a radiator in the Committee Room. The security camera system has needed attention, a costly replacement of the posts around the car park is under way, attention to the trees identified in the recent survey, considerable increase in the cost of electricity and gas supplies, electrical servcing and repair to some of the outside lighting, and the replacement of the sink in the main hall kitchen. Recently repairs to the south end wall and window, and to the roof have also taken more money from our limited resources.

In view of the above, and the fact that the cost of phase two build will be in the region of Two Hundred Thousand Pounds, the committee have unanimously decided that we are in no position to proceed with the work to provide the foundations for the Phase two building extension so the matter will have to lapse and not be proceeded with.

A completely new planning application may be made some time in the future when fund raising makes the build possible, subject to approval by the city council.

On a positive note, the lettings officer has reported more bookings and enquiries from our regular groups and private hirers.

#### 11.4 Highways Report:

It was suggested, as there had been no response from Sebastian Bures regarding a site visit to the Tyler Hill Road/Crab and Winkle crossover, to write to Simon Jones of KCC.

## 12. Matters raised by the Public:

- **1.** David Gammon raised the matter of notices in the village indicating that two thousand homes were to be built land owned by the University.
- Cllr Hutt responded that there has recently been a 'Call for sites' by CCC but there are no applications on the horizon at the present time.
- **2**. The matter of pavement parking opposite the shops was also raised to which Cllr. Flack said that a Police Officer can only issue a ticket if a person is in the vehicle whereas a Parking Enforcement Officer can issue a PCN. Officers do come and attend but residents need to keep reporting cases. It was also noted that the disabled space needs repainting.
- 3. A resident had written to BPC with a request to have the conifers between their property and the recreation ground trimmed with work needing doing on a damaged tree/branch.
- Following a discussion, it was agreed to ask Goodfellers Tree Surgeons to take out the damaged tree/branch and give a quote for taking down the conifers out of nesting season.

#### 13. Matters to be discussed:

## 13.1 Plaque for Rowan Tree and Jubilee Gathering:

After discussion, it was agreed to be suggested to residents to bring a picnic to the recreation ground. This will be put on the Facebook Blean Residents page.

The wording of the plaque to be positioned by the recently planted Rowan tree for the Platinum Jubilee was discussed.

**13.2 Update on Speedwatch:** Cllr. Akers is taking on the task of rejuvenating the village Speedwatch scheme of which there are five volunteers at the present time. It is hoped more will come forward. Cllr. Russell offered to help him with the administrative tasks.

- **14.3 Cllr. Akers** had asked villagers for their thoughts on the recycling bins but had had no response so had not carried it any further.

Cllr. Flack responded that the red boxes are the only solution as the blue inserts are not manufactured anymore.

**14.4 Cllr. Hutt** reminded Councillors of the online CCC training on 6<sup>th</sup> June.

E-scooters are still being tested on Canterbury's streets. The following gives a break down on how these test are progressing:

## Update 6 May 2022

The Department for Transport (DfT) have granted a further extension of the Canterbury electric scooter rental trial, which had been set to end on 31 March. The trial will now run until the end of November 2022.

To facilitate this extension, the Experimental Traffic Regulation Order, which can only be in place for up to 18 months, must be made permanent for the rest of the trial period. However, the <u>Made Order</u> can be revoked at any point. This only allows the use of the Bird trial e-scooters. The use of all other e-scooters remains illegal.

The extension is to allow more data about the use of electric scooters to be gathered and reported back to DfT. The extension only permits Bird e-scooters to be used in Canterbury.



aims to bring affordable, environmentally friendly e-scooters to the city as part of a Department for Transport (DfT) national trial.

Throughout the trial, only e-scooters provided by Bird on a rental basis are allowed. You can register to rent an e-scooter through the Bird app. You can download this through:

- Google Play(External link)
- Apple Store(External link).

Any private e-scooter use on the highway remains illegal.

The e-scooters use the same road space as bicycles and are not permitted to travel on the pavement, or outside of the trial area.

The trial has been delivered in phases so that we can listen to feedback and review safety and usage data. More information on the trial is available from the Documents section on this webpage.

The consultation period for the Experimental Traffic Regulation Order (External link) ran for six months from the 30 October 2020 to 3 May 2021. This was followed by a second consultation, from the 3 June to 31 August 2021 as the trial expanded to the wider urban area. The consultation reports for these consultations will be made available on this webpage.
